Cheques / Postal Orders payable to: Hillingdon & Uxbridge M.C. If a non starter it is required that you explain your absence to the promoting club. Failure to do so is a breach of the Rules.
- COURSE:** 4 laps without roadwork. 3 Routes (White, Red and Blue).
- CLASSES:** A: - WHITE-Hard Route; B: - RED-Middle Route; C: - BLUE-Easy Route
- AWARDS:** Club Bultaco Trophy to best rider on a genuine period twin-shock on the hard WHITE route. No other awards.
- MEDICATION:** It is your responsibility to declare at signing on if you are taking any drugs; you may be tested.
